

LICENSE AGREEMENT

This unilateral contract is an agreement between you, the Licensee, and AJH Associates.

You, the licensee, by the act of using the software on the diskette provided, agree to be bound by the terms of this agreement. Do not use the software without first reading, understanding, and agreeing to the terms and conditions of this agreement. If you do not agree with the terms of this License, return the unused Software immediately to distributor from which it was obtained for a full refund; the seal on the envelope containing the software must be unbroken.

1. **LICENSE.** In Consideration of your payment of the required license fee, AJH Associates agrees to grant you (hereinafter called "Licensee") a nonexclusive, single site license to use the enclosed Quick Response System II and General Network Editor subject to the terms and conditions set forth in this License Agreement.
2. **OWNERSHIP.** As a Licensee, Licensee owns the magnetic or other physical media on which the Software is originally or subsequently recorded. This License is not a sale of the Software or any copy thereof. The software is protected by United States and International copyright law and any infringement of this copyright is subject to prosecution and will be prosecuted upon discovery. Violators are subject to both civil and criminal penalties.
3. **USE.** The Software may be used on any number of computers within Licensee's department, which is defined as a single organizational unit or entity, having a unique function in a single location, and any and all persons using these copies are also Licensees. This license also authorizes Licensee to use the Software on portable computers while on official travel and on home computers, so long as all such use is on behalf of the office for which the Software License was purchased. Branch offices and sub-offices not located at the same geographic location are not licensed to use this software even if the software may be stored on a portable computer. 4. **TRAINING PURPOSES.** The Software may not be used for multi-participant classroom or workshop instruction without the express, written consent of AJH Associates. rent, lease, sell or otherwise dispose of the Software on a temporary or permanent basis except as expressly provided herein.

7. SUPPORT. AJH Associates may from time to time revise or update the Software to correct bugs or add minor improvements. AJH Associates will supply, at its discretion, such minor updates to Licensee without additional charge (except for postage), and will provide reasonable telephone support to Licensee during AJH Associates' normal business hours, (1) for 30 minutes of technical assistance by phone or email, and (2) for such subsequent periods for which Licensee shall have paid the fee established by AJH Associates for such full support services. AJH Associates reserves the right to determine the reasonableness of the support. AJH Associates reserves the right to make substantial revisions and enhancements to the Software and to market such substantially revised versions as separate products. Licensee shall not be entitled to receive such separate products without additional charge, unless Licensee has purchased product within previous 60 days. Upon release of any such revised version of the Software, AJH Associates' obligation to provide additional new bug fixes to the old version of the software is terminated. Previously announced bug fixes to the older version will still be supplied for a period of 1 year after a new version is announced.

AJH Associates warrants the magnetic medium on which the Software is furnished to be free from defects in material and workmanship under normal use for a period of thirty (30) days from the date of delivery to Licensee as evidenced by a copy of invoice. AJH Associates' entire liability and Licensee's exclusive remedy shall be the replacement of any diskette or CD-ROM found to be defective. Defective diskettes or CD-ROMs should be returned with a copy of Licensee's invoice, to the distributor from which the Software was obtained. It is the responsibility of the Licensee to understand fully the limitations of and assumptions underlying the Software and not to make use of the Software without the assistance of personnel with appropriate expertise. Licensee accepts all responsibility for review, application, and the use of the program output and accepts all responsibility for certification that said output meets provisions of any applicable design code, standard or any project specification.
